Individual collection

Monday through Friday (except Saturday, Sunday, National Holiday, Holiday, the period of Dec.28 to Jan.4)

- ※We also give opportunities of individual collection two Sundays in a month. Please call Recycle Plaza about the date for it.
- ※Collecting charge is 600 yen per one time (consumption tax will be charged separately) and disposal charge is 150 yen per 10 kg (consumption tax will be charged separately)

Self-carry-in

Monday through Friday (from 9 to 11:30 am, 1 to 2:30 pm) (except Saturday, Sunday, National Holiday, Holiday, the period of Dec.28 to Jan.4)

- ※You cannot carry in bulky waste on non-burnable collection day of the third week of each month.
- ※Please be sure to apply for it to the Recycle Plaza before you carrying in your items.
- ※Disposal charge is 150 yen per 10 kg (consumption tax will be charged separately)

Collectable items

Items except 'burnable waste', 'pet bottles', 'recyclable bottles and cans', 'recyclable papers and clothes', 'non-burnable hazardous waste', 'items which are not collected by the city'.

- Furniture: tables, desks, chairs, chest of drawers, carpets etc.
- Bedclothes : quilts, futon (Japanese mattress), beds etc.
- Large electrical home appliances: furniture-like kotatsu (Japanese table with heater), large fan heaters.
- Snow boards ● Bicycles ● Scrapped storages etc.
- Thin futon (Japanese mattress), thin mattress ● Scrapped small shelves etc.

Burnable items which are able to cut or fold into the size less than 50cm are treated as burnable waste.

- Carpets that are around two tatami-mat size.
 - Thin futon (Japanese mattress), thin mattress ● Scrapped small shelves etc.
- Place these items as burnable waste after putting in a 45-liter bag or binding up.

Incombustible items containing metal parts are regarded as "Unburnable Waste" if less than 1m in length, and 10 kg in weight.

- Electric carpet ● Legless chair ● Folding chair
- Small-sized kotatsu ● Bicycle for infants etc.

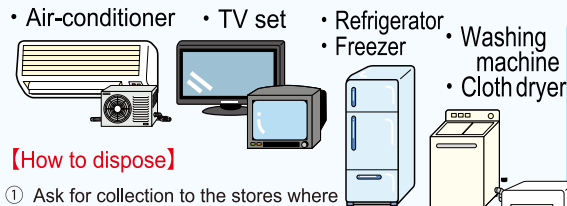
Attention

*For TV set (cathode-ray tube, liquid crystal, plasma), air-conditioner, refrigerator, freezer, washing machine, cloth dryer, PC, see below for "Items which can't be collected by the city"

- Don't place them at the waste collection site.
- Those who applied for individual collection should place bulky items on the ground outdoor on collection day.
- Items added on the collection day can't be collected.
- On the collection day, you are required to be present at the collection.

[How to dispose]

- ① Ask for collection to the stores where you bought replacement items, or you bought the item.
- ② Ask authorized waste management service agencies who are permitted by Yashio-shi (→P.16). Charge required.
- ③ Take items directly to the designated place (→p.16). Charge required.

Personal computers



By Law for Promotion of Effective Utilization of Resources, PCs and display monitors must be collected and recycled by manufacturers. For more information about disposal, ask each manufacturers or PC3R Promotion Association .

Unacceptable items

- Extinguisher ● tires ● Piano ● Soil ● Gravel ● Tiles
- Stones ● Waste oil ● Medical waste ● Sludge ● Debris ● Concrete block ● Concrete ● Plaster board
- Building material ● Car battery ● Waste acid ● Waste alkali ● Paint ● Fireproof safe



[Disposal] Ask stores or professional disposal agents.

Large quantity of waste

Large quantity of waste due to moving, big clean-up of house, or pruned twigs or branches from garden



[Disposal] Contact authorized waste management service agencies who are permitted by Yashio-shi (→P.16) for collection. Ask them the price for disposal and collection.

Business waste

Waste produced by business organizations (restaurants, shops, factories, firms, offices, hospitals etc.)

As business owners should take responsibility to properly dispose of waste produced by business activities under the laws and regulations, business waste **can't be placed at the waste collection site for household waste**. For collection, ask authorized waste management service agencies who are permitted by Yashio-shi (→P.16). Even if they are the same types as household waste such as burnable waste, bottles, cans, PET bottles etc, they are regarded as **business waste**.
